Upon receipt of your completed application, we will check whether your tenancy and property are suitable for the requested works. We may need to contact you to ask for more information or to visit your property and set conditions that you must meet before we grant permission.

We will attempt to acknowledge to your application within 10 working days. You must not begin any work without SHIAN's written permission.
